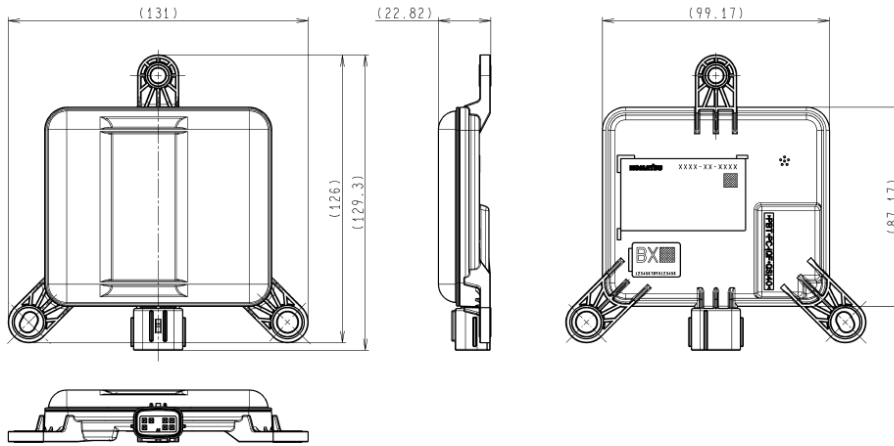


Figure 1. 24GMMR1A

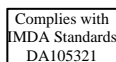
