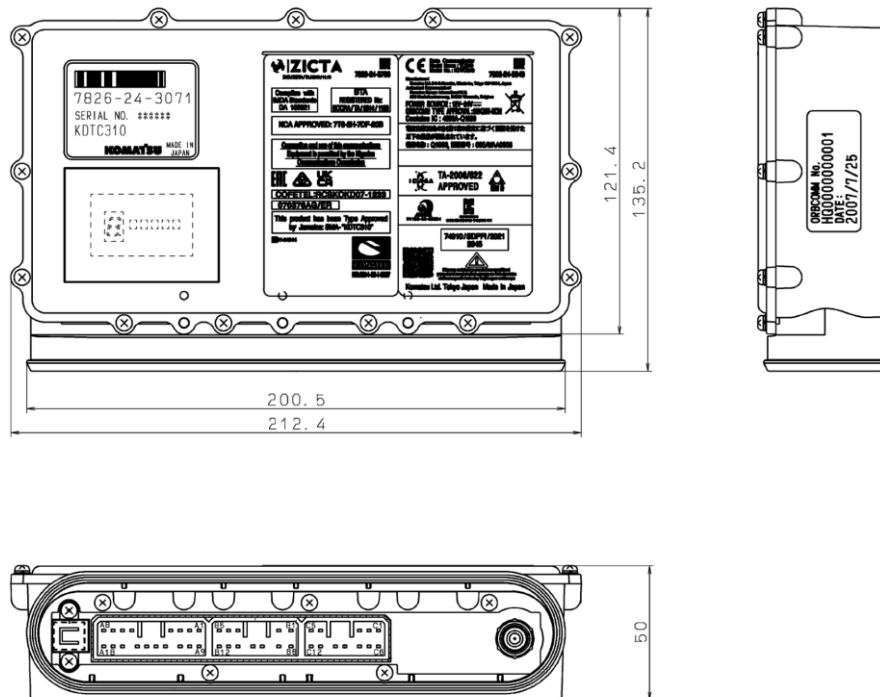


Figure 1 KDTC310 Dimensions
