TG-D3X is a Topcon full-wave antenna that provides reliable solutions by tracking GPS, GLONASS, BeiDou, Galileo, QZSS, SBAS and L-Band satellites.

This high precision antenna with integrated ground plane provides excellent tracking sensitivity and multipath rejection for all surveying and construction applications.

The TG-D3X antenna supports a wide range of GNSS constellations.

Paired with any Topcon modular or handheld GNSS receiver provides a high performance RTK system.

The TG-D3X antenna system offers IP6X dust and IP7X water resistance under IEC60529 as well as superior level of vibration and shock tolerance (MIL-STD-810H).
